

4. APAR of the officers will be initiated soon after their SOS date, if they have completed three months or more in the current APAR year under the reporting officer.
5. Before moving the officer to sensitive appointment, the provisions as envisaged in Govt of India, department of personal training OM No 22011/4/91-Estt(A) dt 14 Sep 1992 shall be strictly adhered to. Disciplinary cases shall invariably be referred back to this HQ.
6. **Before relieving the officer, the head of the office will ensure submission of AIPR year ending Dec 2016 by the officer. In case of non submission of AIPR, the same will be intimated immediately to this HQ for placing the officer to non-sensitive appointment and taking action against him as per DOP&T guidelines.**
