2. **Relief of certain officer posted out has not been provided due to acute deficiency of the officers available for posting. In view of this, the move of the officer shall be implemented by the due date and no officer to be held back on ground for non-provision of relief.**
3. **Departure/arrival of the officer will be reported to this HQ (E1B/MIS ADP/MIS (Civ) by signal/fax by the relieving/receiving unit on the day of their SOS/TOS. Movement order of officer will also be sent to this HQ within 48 Hrs from the date of issue of movement order.**
4. **APAR of the officers will be initiated soon after their SOS date, if they have completed three months or more in the current APAR year under the reporting officer.**
5. **Before moving the officer to sensitive appointment, the provisions as envisaged in Govt of India, department of personal training OM No 22011/4/91-Estt(A) dt 14 Sep 1992 shall be strictly adhered to. Disciplinary cases shall invariably be referred back to this HQ.**
6. **Before relieving the officer, the head of the office will ensure submission of AIPR year ending Dec 2017 by the officer. In case of non submission of AIPR, the same will be intimated immediately to this HQ for placing the officer to non-sensitive appointment and taking action against him as per DOP&T guidelines.**
