POLICY : FORGO/ NON IMPLEMENTATION OF POSTING ON PROMOTION

1. Conduct of DPCs for subordinate ranks is a regular process. When Group 'B' offrs do get promoted from non-gazetted to gazetted rank their postings are issued according to their profile. Offrs get promoted on assumption of appt in the new duty stn.
2. The policy on the subject is absolutely clear on various aspects of **representation, forgo and expiry of promotion panel**. However certain units/ offices are defaulting on timely implementation of postings there by complicating the issue resulting in **legal cases**. Policy matters related to Group 'B' offrs on **promotion-cum-posting** are being reiterated for compliance.
 - (a) All promotion postings are issued **forthwith** as move date and should be complied with.
 - (b) Offrs representing against the posting should process their application within **one month** with '**Recommendations**' in chain of Comd. An advance copy be faxed to E1B, E-in-C's Branch duly recommended by immediate superior HQ, so as to reach within **15 days** of issue of posting (**Ref Para 24 (a) of posting policy**).
 - (c) Repeated representations will not be accepted once a decision has been conveyed and will be returned un-actioned. Direct representation to the **E-in-C or DG Pers** will not be admitted (**Refer Para 24 of the posting policy**).


(d) Forego applications received with a conditional clause should not be forwarded. "Offrs request for a particular stn for posting else request for forgo of promotion". Offr may represent either against **postings or forgo promotion** with adequate justification and supporting docu.

(e) Once the decision is conveyed for **forgo/ representation** immediate move of offr if applicable is the responsibility of the controlling offr.

(f) Promotion **panel expires after one year** of issue of DPC panel. Such cases who have not moved and their promotion panel has expired be intimated immediately to **E-in-C's Branch** and **disciplinary** action be initiated. Posting of such offr will be **cancelled** and offr will be posted subsequently as per their profile by respective **Comd HQs**.

(g) Implementation of move is the responsibility of respective controlling offr and should be **held responsible** in case of non-implementation of move within stipulated time.

3. The letter may be **disseminated** to all offices till **GE/ AGE (I) level** for information and strict compliance.
